

# **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

Triple Point is currently in the process of setting Science-based targets across its financed emissions, as the most material part of its Scope 3 footprint. Financed emissions (Scope 3, Category 15) have not yet been finalised, and are omitted from the above emissions reporting. We anticipate that these targets will be finalised by the end of 2023 and, as an organisation, this is where the majority of carbon reduction initiatives will be focused.

For our operational Scope 1 & 2 emissions, we project that carbon emissions will decrease over the next five years to 9.5 tCO<sub>2</sub>e by 2026. This is a reduction of 23%



## **Carbon Reduction Projects**

### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented since the 2021 baseline.

- Introduced an electric vehicle leasing scheme for all employees
- Made bicycle repair tools and spare parts in the office
- Reduced the use of single-use plastics in the office
- Utilised materials with a high percentage of recycled content in our recent office renovation

In the future we hope to implement further measures such as:

- Committing to a Science-based target covering our operational Scope 1 & 2 emissions, and our Scope 3, Category 15 emissions
- Engaging with our building manager to reduce natural gas consumption in the office and allow for waste data collection
- Enhancing our data collection to allow for more accurate business travel data, and implementing policies to encourage more sustainable methods of travel

# **Declaration and Sign Off**

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.
